





Temporary tram line closure for construction



- To fast-track construction and reduce impacts on residents, businesses, road and public transport users, we will be temporarily closing the Glenelg tram line.
- Trams will continue to operate through the City from the existing South Terrace Tram Stop.
- Substitute buses will be in place during this time to service the remaining tram network between South Terrace and Glenelg.
- The tram line closure will commence in the second half of 2025.
- We will have the tram line ready for testing and commissioning late 2025 with services scheduled to resume late January 2026 in time for the start of the school term.










Tram operations during closure



- Substitute buses will transfer passengers at South Terrace to catch trams during the closure, with temporary tram stabling at the same location.
- Options considered for stabling of trams:
 - South Terrace
 - East End on North Terrace
 - Adelaide Entertainment Centre
- South Terrace was selected as the site allows stabling and operations activities to be completed within the existing corridor.
- Temporary infrastructure will be built to facilitate this and removed at completion.










Interface with City of Adelaide projects

- During the tramline closure substitute buses will transfer passengers at South Terrace to catch trams during the closure.
- TGSP Alliance recognise the City of Adelaide is planning to upgrade the bikeway along Peacock Road.
- TGSP Alliance will work closely with CoA to ensure that substitute bus operations, tram stabling and bike path activities are coordinated.











Enabling works for temporary tram line closure

- To facilitate the temporary tram line closure in mid-2025, there will be some works undertaken prior to the closure
- These works will involve short-term tram service disruptions
- Infrastructure will be upgraded to enable city services to remain operational during the major occupation
- More information on service disruptions will be provided closer to the time, in advance of any impacts







South Terrace Tram Stabling Facility


- To prepare for the temporary tram line closure, we will establish a temporary tram stabling facility
- This will be within the existing tram corridor alongside Peacock Road, Adelaide.
 The facility will enable tram services to continue running from South Terrace to:
 - the Entertainment Centre
 - Botanic Gardens.
- In addition, we will also modify the existing signalling system to support the City tram services. Temporary building and storage containers will be removed at the completion of the project, with the area reinstated to its former condition.







Temporary tram maintenance facility











- TGSP Alliance are requesting to utilise the 1-hour parking adjacent to the Adelaide Pavilion
- 30 car parks for operational needs from mid-2025 until early 2026
- Temporary requirements:
 - Fencing
 - Gate
 - Walkway
 - Lighting
- TGSP Alliance will remove infrastructure and reinstate the area in early 2026.











Minor tree pruning



- Minor tree pruning will be undertaken during establishment of the stabling facility
- Torrens Connect standard maintenance activities will take place as required (i.e. general maintenance, tree pruning)









| Other Funding Sources | The Mount Lofty Consortium (the Consortium) has noted that there is approximately \$60,000 remaining in a fund set up by the Consortium to contribute towards the ongoing development of the World Heritage bid. Until there is clarity in the World Heritage Governance arrangements, this funding is being retained by the Consortium (Adelaide Hills Council). There is no external funding source currently committed or allocated to the project. Funding opportunities will be identified in the process and sought from partners. |

Kadaltilla / Adelaide Park Lands Authority Meeting – Agenda - Thursday, 27 March 2025

Discussion

Current Status

- 1. The City of Adelaide is continuing to liaise with World Heritage expert Duncan Marshall AM to discuss the next steps required to progress a World Heritage Tentative List Submission to align with a February 2026 timeframe.
- 2. The Administration has met separately with the Cultural Heritage Section, World and National Heritage Branch of the Department of Climate Change, Energy, the Environment and Water (DCCEEW, Cth) and the Heritage SA, Department for Environment and Water (DEW) to advise of the intention to seek acceptance of a Tentative List Submission by February 2026.
- 3. Administration has had clear direction that Free, Prior and Informed Consent (FPIC) must be demonstrated for all stages of the World Heritage Project.
- 4. FPIC is a process and methodology for undertaking early consultation and engagement to facilitate understanding and receive consent from Aboriginal and Torres Strait Islander peoples for proposed actions affecting their lands and communities.
- 5. The process must be free from coercion and allow the time and resources to enable traditional decision-making by the Aboriginal and Torres Strait Islander community.
- 6. A report regarding the use of Free, Prior and Informed Consent principles for the World Heritage project was presented at the 5 March 2025 Reconciliation Committee meeting.
 - 6.1. Administration is progressing the procurement of a report into the integration of Aboriginal and Torres Strait Islander engagement in line with Free, Prior and Informed Consent principles into Council processes.
 - 6.2. The recommendations of this report will inform the approach to engagement for the World Heritage Bid with the work targeting completion by 31 December 2025.
- 7. Through the Quarter 3, 2024/25 budget review process funding has been confirmed to commence engagement of SA Native Title Services (SANTS) to scope and facilitate appropriate and meaningful engagement for the Tentative List Submission with Aboriginal and Torres Strait Islander stakeholders. This work is targeting completion by 31 December 2025.
- 8. Administration has prepared a substantial promotional piece on the World Heritage Bid to feature on the History Trust's social media campaign for the SA History Festival in May 2025.

Related Activity

- 9. Administration continues to undertake research and attribute mapping based on Duncan Marshall's report for the purposes of clarifying the areas that may one day form part of the World Heritage property.
 - 9.1. The City of Adelaide will be hosting two heritage research Master of Architecture interns through University Semester 1, 2025 to assist with the collation of information and mapping.
- 10. A funding application was submitted in February 2025 with the support of Kaurna Yerta Aboriginal Corporation (KYAC), through Round 2 of the Commonwealth Government First Nations Heritage Grants program. If successful, the grant will assist with:
 - 10.1. First Nations research and formally identifying Kaurna Heritage Values of the Adelaide Park Lands that can be incorporated into the existing National Heritage listing and World Heritage bid.
 - 10.2. Providing greater recognition and protection of Kaurna Heritage Values in the development of the World Heritage bid.
- 11. Administration is implementing the recommendations of the of the National Heritage Management Plan, through the following projects in 2024/25:
 - 11.1. A Historic Landscape and Plantings Management Plan, including identification and mapping of historic designed landscapes and plantings relating to the National Heritage Values.
 - 11.2. A desktop Archaeological Survey of the Adelaide Park Lands to identify areas with a high likelihood of uncovering remains that may contribute to our understanding of the State's history.

Next Steps

- 12. The next steps to be undertaken for the World Heritage Bid are to:
 - 12.1. Finalise the World Heritage Tentative List submission through the 2024/25 and 2025/26 financial years.
 - 12.2. Complete the analysis to embed Free, Prior and Informed Consent processes into Council processes.

- 12.3. Work with SA Native Title Services to engage with KYAC and other relevant Aboriginal stakeholders to obtain their support and consent for lodging the Tentative Submission with the State Government.

Purpose

Exclusion of the public from this meeting is sought for the consideration of the following Agenda Item:

10.1 Statues Commemorating South Australian Aboriginal Leaders Proposal [section 90(3) (j) of the Act].

Meetings of Kadaltilla must be conducted in a place open to the public except in special circumstances. Special circumstances and associated considerations to exclude the public from a meeting are outlined in section 90 the *Local Government Act 1999 (SA)* (the Act).

Clause 4.8.21 of the Charter enables Kadaltilla, to order the exclusion of the public from attendance to consider in confidence any information or matter listed in section 90(3) of the Act. The exercise of this power does not exclude Board Members and/or any other person permitted by Kadaltilla to remain in the room.

The Order to Exclude for Items 10.1:

- 1. Identifies the information and matters (**grounds**) from section 90(3) of the Act utilised to request consideration in confidence.
- 2. Identifies the **basis** how the information falls within the grounds identified and why it is necessary and appropriate to act in a meeting closed to the public; and
- 3. In addition, identifies for the following grounds section 90(3) (b), (d) or (j) how information open to the public would be contrary to the **public interest**.

All Board members must keep confidential all documents and any information presented to them for consideration on a confidential basis prior to the meeting.

Order to Exclude for Item 10.1

THAT THE ADELAIDE PARK LANDS AUTHORITY

1. Having taken into account the relevant considerations contained in Clause 4.8.21 of the Adelaide Park Lands Authority Charter and section 90(3) (j) and 90(2) & (7) of the *Local Government Act 1999* (SA), this meeting of the Board of Kadaltilla / Park Lands Authority dated 27 March 2025 resolves that it is necessary and appropriate to act in a meeting closed to the public as the consideration of Item 10.1 [Statues Commemorating South Australian Aboriginal Leaders Proposal] listed on the Agenda in a meeting open to the public would on balance be contrary to the public interest.

Grounds and Basis

This Item contains material provided on a confidential basis which the State Government has requested be considered in confidence on the grounds that the details of the request are sensitive in nature and the release of this information prematurely may be misleading. The disclosure of information in this report could reasonably be expected to prejudice the position and any negotiations between the City of Adelaide and the State Government.

Kadaltilla / Adelaide Park Lands Authority Meeting – Agenda - Thursday, 27 March 2025

Public Interest

The Kadaltilla / Adelaide Park Lands Authority is satisfied that the principle that the meeting be conducted in a place open to the public has been outweighed in the circumstances because the disclosure of information may result in release of information prior to the finalisation of the matter by the State Government and the City of Adelaide. The disclosure of this information may materially and adversely affect the viability of the matter and prejudice the ability of the parties to discuss/participate or influence a proposal for the benefit of the State Government, the City of Adelaide and the community in this matter which on balance would be contrary to the public interest.

2. Pursuant to section 90(2) of the *Local Government Act 1999 (SA)* (the Act), this meeting of Kadaltilla dated 27 March 2025 orders that the public (with the exception of members of Corporation staff and any person permitted to remain) be excluded from this meeting to enable this meeting to receive, discuss or consider in confidence Item 10.1 listed in the Agenda, on the grounds that such item of business, contains information and matters of a kind referred to in section 90(3) of the Act.

Kadaltilla / Adelaide Park Lands Authority Meeting - Agenda - Thursday, 27 March 2025

Discussion

- The Adelaide Park Lands Act 2005 (SA) requires the Authority to operate utilising Chapter 6 Part 3 of the Local Government Act 1999 (SA) (the Act). Chapter 6 Part 3 relates to public access to meetings and outlines the conduct to be observed by the Authority.
- 2. It is a requirement of the *Adelaide Park Lands Act 2005 (SA)* [13 (c)] reflected in clause 4.8.19 of the *Adelaide Park Lands Charter* (Charter), that meetings of the Authority be conducted in a place open to the public except in special circumstances. These circumstances and associated considerations to exclude the public from a Board meeting are outlined in Chapter 6, Part 3 of the Act.
- 3. In considering whether an order should be made to exclude the public the order must specify
 - 3.1. the grounds on which the order was made; and
 - 3.2. the basis on which the information or matter to which the order relates falls within the ambit of each ground on which the order was made; and
 - 3.3. if relevant, the reasons that receipt, consideration or discussion of the information or matter in a meeting open to the public would be contrary to the public interest.
- 4. In considering whether an order should be made to exclude the public, it is irrelevant that discussion of a matter in public may:
 - 4.1. cause embarrassment to the council or council committee concerned, or to members or employees of the council; or
 - 4.2. cause a loss of confidence in the council or council committee.
 - 4.3. involve discussion of a matter that is controversial within the council area; or
 - 4.4. make the council susceptible to adverse criticism
- 5. When determining whether to exclude the public from the meeting the Authority is required to consider & resolve whether it is necessary and appropriate to act in a meeting closed to the public to consider the following information in confidence.
 - 5.1. Information contained in Item 10.1 [Statues Commemorating South Australian Aboriginal Leaders Proposal]
 - 5.1.1. Is not subject to an existing Kadaltilla / Park Lands Authority Confidentiality Order
 - 5.1.2. Is subject to an existing City of Adelaide Reconciliation Committee Confidentiality Order
 - 5.1.3. The grounds utilised to request consideration in confidence is s 90(3) (j) (i) (ii) of the *Local Government Act 1999 (SA)*
 - (j) information the disclosure of which -
 - (i) would divulge information provided on a confidential basis by or to a Minister of the Crown, or another public authority or official (not being an employee of the council, or a person engaged by the council); and
 - (ii) would, on balance, be contrary to the public interest
