The Presiding Member provided a verbal report indicating:

- On 27 March 2025, the three new Kadaltilla Board Members were officially gazetted. The Lord Mayor welcomed Warwick Keates and Kirsty Bevan to their first meeting of the board, and acknowledged Sarah Russo who will serve as proxy member to Stephanie Johnston.
- City of Adelaide – Draft Cultural Policy Consultation Now Open
 - Consultation on the Draft Cultural Policy is now open, with feedback requested by 9:00am Monday 5 May 2025.
- Informal Hard Stand Car Park in Bonython Park
 - The Lord Mayor informed the board that SA Water will be occupying the entire informal hard stand car park in Bonython Park / Tulya Wardli (Park 27) from 5 May 2025 for essential works relating to construction of the new Women's and Children's Hospital.
 - Access to the car park will be closed to the public during this time. It is expected to be in place until December 2025. This is subject to change.
 - Signage is in place to notify users of the impending closure.
- The Lord Mayor informed the board that on Friday 11 April 2025, the Court of Disputed Returns made orders regarding the 2022 Central Ward election and advised that:
 - Preparation for the supplementary election has commenced with Council administration working in collaboration with the Electoral Commission of South Australia (ECSA).
 - The supplementary election will not impact Kadaltilla Board membership.

2. Endorses Council progressing with negotiations and execution of a Deed of Agreement to be based on the same, or similar terms, to that of the existing Deed and the key terms included in section 16 of this report, and including:
 - 2.1. A minimum 10% reduction to existing car parking on land managed by the City of Adelaide based on the 2022 baseline.
 - 2.2. Maintaining no parking within Biodiversity Areas.
