EXECUTIVE SUMMARY

The purpose of this report is to enable the Reconciliation Committee to agree on Dual Chairpersons and Deputy Chairperson of the Reconciliation Committee.

On 13 December 2022, Council established the City of Adelaide Reconciliation Committee for the 2022-2026 municipal term and appointed Council Members and external members to the Committee. Council also appointed the Lord Mayor as one of the Dual Chairpersons.

In establishing the City of Adelaide Reconciliation Committee, Council delegated to the Committee the authority to determine the persons to undertake the roles of Dual Chairpersons and Deputy Chairperson.

This report invites the Committee to make the appointment of the roles of Dual Chairpersons and Deputy Chairperson for two years from 2022-2024.

 - 2.1.5. Kaurna Yerta Aboriginal Corporation.
 - 2.2. Council agreed on 13 December 2022 that the following agencies and organisations would be approached to nominate members to the Committee. We are in the process of receiving nominations from them and we expect that the appointments will be finalised by 1 March 2023:
 - 2.2.1. Reconciliation South Australia
 - 2.2.2. Aboriginal Affairs and Reconciliation, Attorney General's Department
 - 2.2.3. Aboriginal Health Council of South Australia.
3. As per the Council decision on 13 December 2022 and as per the [Reconciliation Committee 2022-2026 Adopted Terms of Reference](#), the Reconciliation Committee is now asked to appoint for a period of two years:
 - 3.1. One community representative member to the role of Dual Chairpersons. This representative will undertake this role alongside the Lord Mayor.
 - 3.2. One community representative member to the role of Deputy Chairperson.
4. The nomination and appointment process are subject to provisions pursuant to City of Adelaide Standing Orders (162 and 167), which state:
 - 4.1. Unless determined otherwise by Council, in the event of more nominations than required, an election by voting ballot of all Council Members present will be undertaken to select a nominee.
 - 4.2. At the conclusion of a voting ballot or drawing of lots, a resolution of the Council will be required to confirm the outcome of the election process.
5. Selecting Dual Chairpersons enables equal participation by both Council Members and Aboriginal and Torres Strait Islander members of the Reconciliation Committee and promotes a shared responsibility for advancing reconciliation in the city.
6. The two-year term of the Chairperson appointments is consistent with Council's Committee structure and a further appointment of Dual Chairpersons and Deputy Chairperson will be undertaken at the last Reconciliation Committee meeting in 2024.

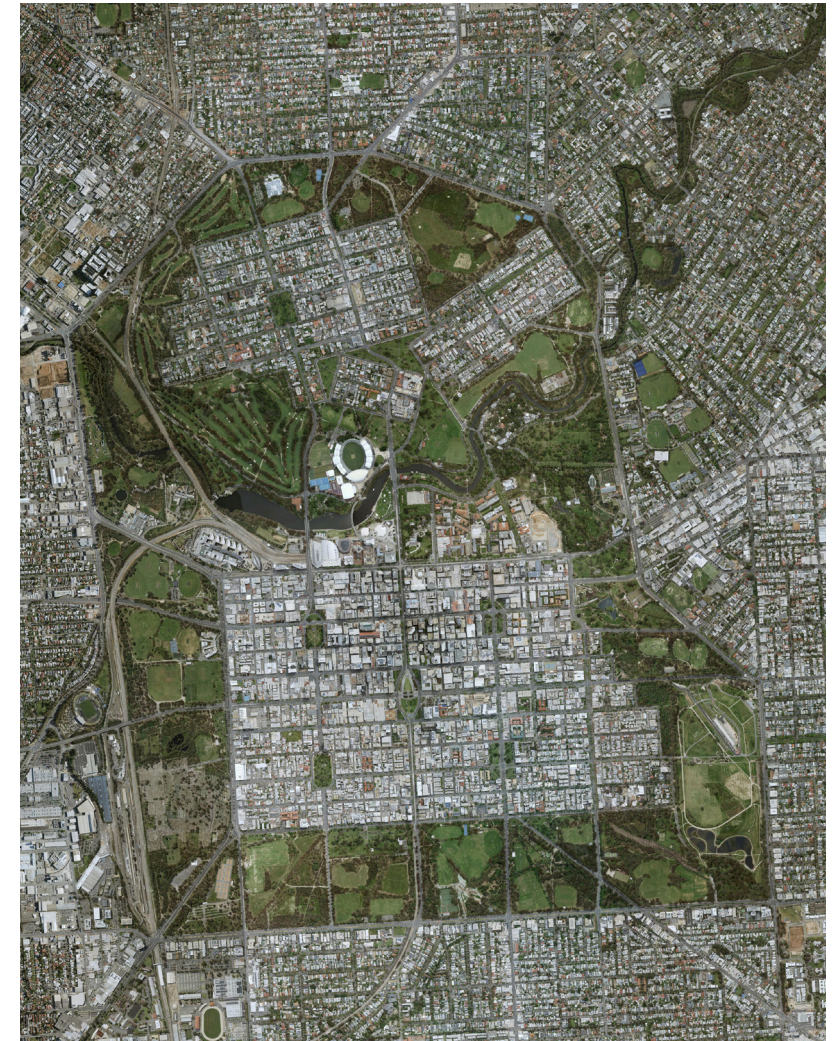

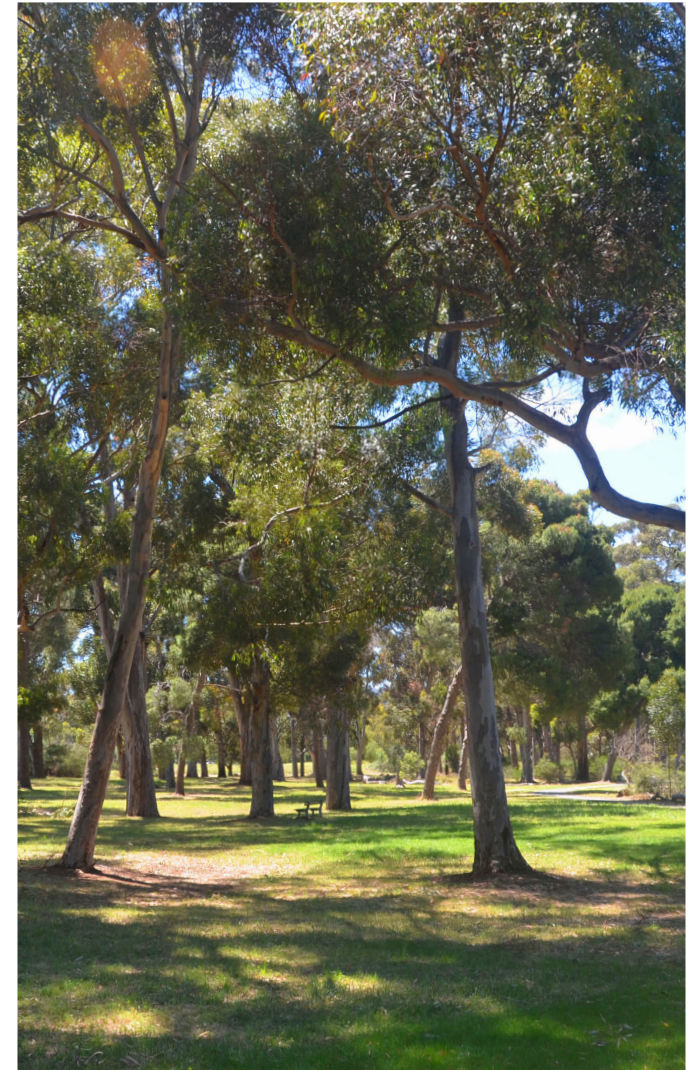

Project Background

Why is a Heritage Management Plan Required?

- > **Adelaide Park Lands and City Layout** was entered on the National Heritage List in 2008 as a “a masterwork of urban design and signifies a turning point in the settlement of Australia...[and it is] the most extensive and substantially intact nineteenth-century park lands in Australia.”
- > **A HMP is a non-statutory requirement for a place not owned by the Commonwealth, “but the Commonwealth Government must use its best endeavours to ensure that a plan for managing a place included in the national Heritage List is prepared and implemented, in co-operation with the state or territory jurisdiction where the place is located.”**



Project Background

What is a Heritage Management Plan?

A Heritage Management Plan:

- > Provides a better understanding of the how the national heritage values are represented.
- > Describes the place in detail
- > Provides an assessment of condition and integrity
- > Identifies constraints and opportunities
- > Develops management policies and strategies for implementation
- > Guided by the principles contained in Schedule 5A of the Environment Protection and Biodiversity Conservation Regulations, (Aus) 2000: 'Management Plans for Commonwealth Heritage Places'
- > Endorsed under the EPBC Act by the Minister for the Environment.



Conservation Policy

The HMP contains policy and actions relating to the conservation of:

Form

- > The overall plan including layout of North and South Adelaide set within encircling Park Lands (often referred to as figure-of-eight form), incorporating gridded street pattern (including hierarchy of roads), six town squares and separated by Karrawirra Parri/River Torrens.
- > Natural Topography
- > Alienation of Land
- > Views & Vistas
- > Shape of City Squares

Fabric & Setting

- > A layered and diverse cultural landscape which reflects the heritage values of: Aboriginal use and cultural significance; European settlement; Light's diagrammatic plan; and the subsequent phases evolution of the city and landscape, including the influence of later designers and revegetation efforts
- > State and local heritage places
- > Significant landscape elements, vegetation, archaeology
- > Proportion of building to Park Land
- > Intrusive elements

Aboriginal cultural heritage

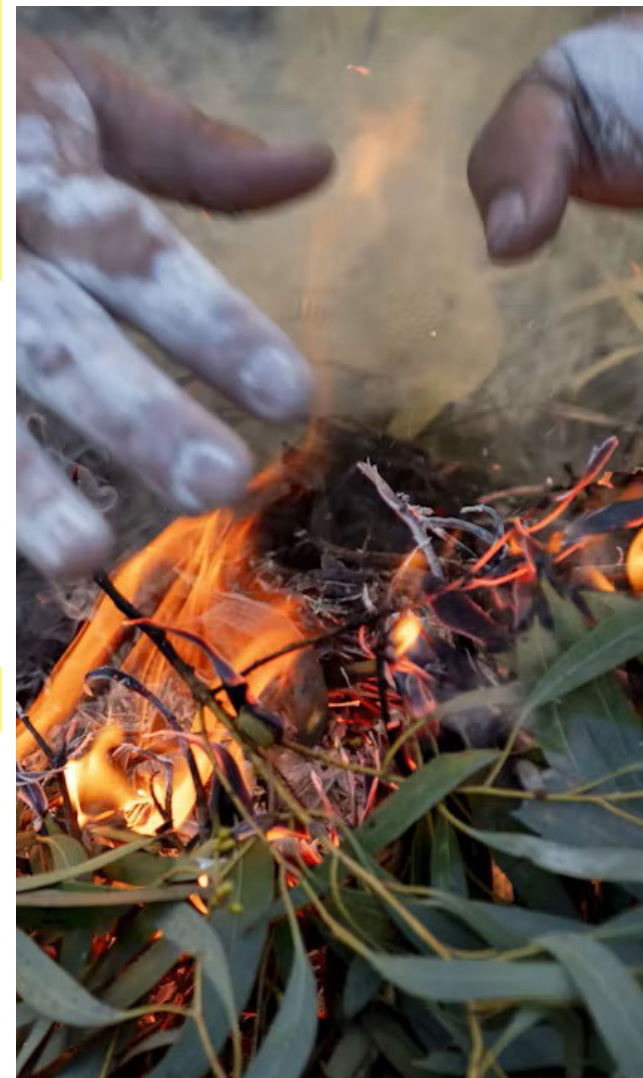

Conservation Policy

Aboriginal Cultural Heritage

4.1 In partnership with the City of Adelaide's Reconciliation Committee, develop strategies to appropriately record, respect, and celebrate Aboriginal heritage within the Park Lands and City Layout.

4.1.1 Implement the actions identified in the City of Adelaide's Reconciliation Action Plan 2021-2024, specifically:

- Develop a Kaurna cultural map
- Identify opportunities for Kaurna street names in the CBD and North Adelaide.
- Develop an opportunity to create a statue of Queen Iparrityi in the CBD.
- Develop employment opportunities for Kaurna people to assist with the management and maintenance of the Park Lands.
- Support and incentivise opportunities for Kaurna run enterprises.
- Educating the CoA employees, the Adelaide community and visitors on the use and importance of the area to the Kaurna people

4.2 Conserve and manage Aboriginal sites and objects in the Park Lands area.

4.2.1 Ensure that prior to the preparation of development proposals, the potential for sub-surface deposits of Aboriginal cultural material is subject to archaeological assessment in consultation with the Kaurna people.

4.2.2 Ensure that works and maintenance service contracts include notice of the potential for unforeseen discovery of Aboriginal cultural heritage, including human remains, and the relevant statutory obligations and notification procedures if a discovery occurs

4.3 Ensure that the publicly accessible areas of the Park Lands continue to be available for use by the traditional owners, the Kaurna people, to maintain their cultural traditions.

4.3.1 Continue to support the restoration of Kaurna cultural traditions to the Park Lands through the Reconciliation process, in partnership with the Kaurna people.

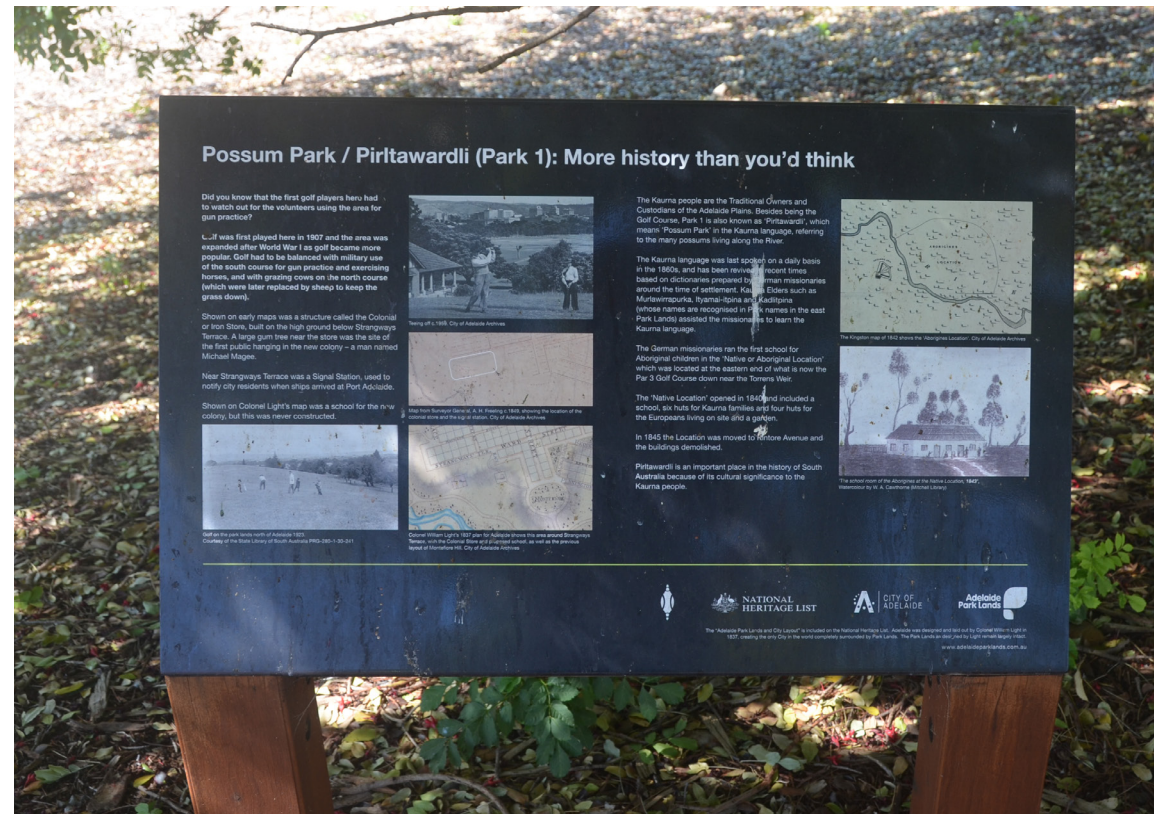
Interpretation

6.2 Celebrate and support Aboriginal cultural heritage interpretation in the Park Lands and City Layout in partnership with the Kaurna people. This should co-exist with interpretation opportunities for European cultural heritage values..

6.2.1 Maintain and promote the Kaurna place naming of Parks and Squares.

6.2.2 In partnership with the Kaurna community, develop an Aboriginal interpretation plan for the area.

6.2.3 Involve Kaurna people in the design and approval of content of any signage proposals.

Place of Reflection

The Place of Reflection is a high-profile public artwork in the City of Adelaide that acknowledges the strength and resilience of the Stolen Generations, their families and friends, and the wider community.

The artwork is being created by respected Ngarrindjeri Elder and artist **Aunty Yvonne Koolmatrie** in collaboration with **Karl Meyer** supported by **Exhibition Studios**.

In October 2022, several workshops were held at **Tandanya National Aboriginal Cultural Centre**.

- The workshops were facilitated by **Rebecca Wessels (Ochre Dawn)** and involved the representatives **Place of Reflection Advisory Group** and other peers from the community.

These workshops were an opportunity to:

- update the Advisory Group on the work to date including the Mother Figure;
- provide inspiration and capture meaningful stories, and interpretive elements that may be incorporated into the Place of Reflection;
- Learn to how to weave from master weaver and artist, Yvonne Koolmatrie;

Place of Reflection

Next Steps:

- Artist team, **Aunty Yvonne Koolmatrie and Karl Meyer** are developing elements of the artwork inspired by the workshops.
- The artistic responses to the workshops will be shared with the **Place of Reflection Project Advisory Group**.
- A smoking ceremony is proposed at the artwork location for early April 2023 in preparation for site works.

We seek Reconciliation Committee's guidance on an appropriate and **prominent location and presence for the statement** in Adelaide Town Hall?

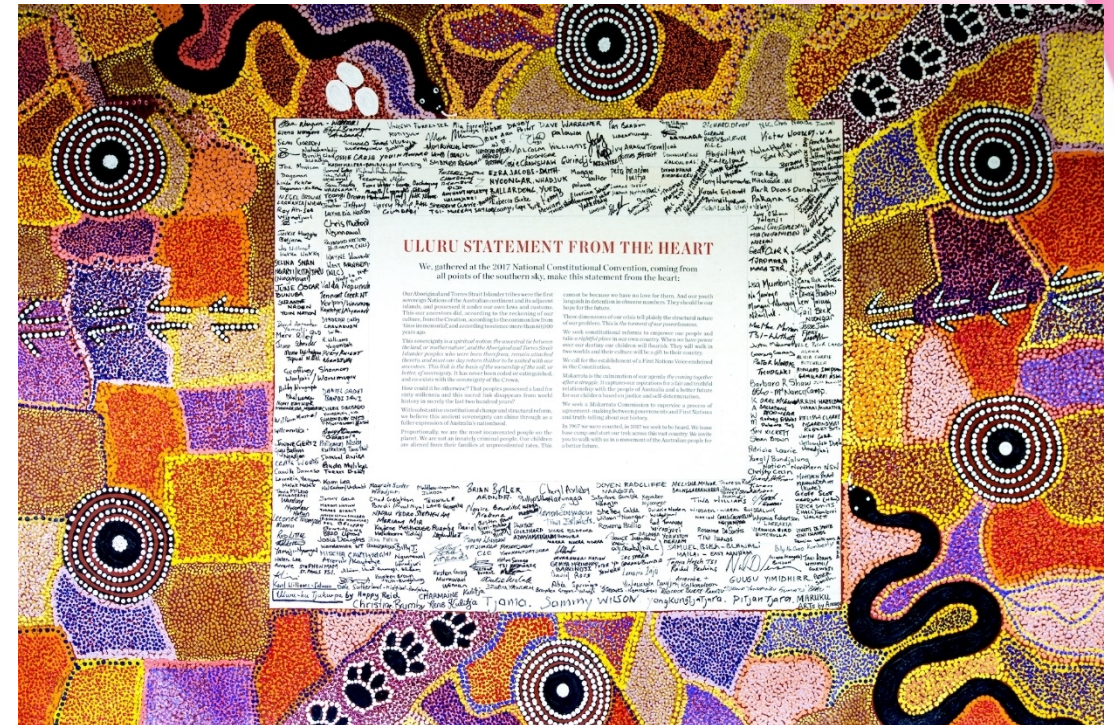
