1. Approves the Memorandum of Understanding between the City of Adelaide and the City of Athens, Greece as contained in Attachment A to Item 7.1 listed on the Agenda for the meeting of the City Community Services and Culture Committee held on 2 September 2025.
2. Notes that the City of Athens has advised the City of Adelaide that the Memorandum of Understanding must be approved first by its municipal council and subsequently by the Greek Ministry of the Interior, before it can be signed by both parties.
